ABOUT THE PROJECT

The proposed project reacts to the upcoming 2024 European Parliament elections, and the general need to understand the underlying mechanisms behind societal polarisation around vital issues that has intensified over recent years, particularly amongst the newer EU Member States. Newer member states, such as the V4 countries, generally have low participation in elections. They tend to veer towards Euroscepticism and high levels of distrust in authorities, institutions and - more broadly - change and transformations.

In order to better comprehend why this is the case, a better understanding of citizens' needs, wishes, concerns and fears is essentia

Sample size: N=1001 (CAPI 401 / CAWI 600)

Location: the whole territory of Poland

Realisation: February 2023
















SO6A. DO YOU PERSONALLY FEEL BELONGING TO EUROPE, DO YOU FEEL EUROPEAN?










SO6B. DO YOU THINK THAT OUR NATIONAL INTERESTS ALIGN WITH THOSE OF THE EUROPEAN UNION?










SO6C. DO YOU SUPPORT THE INTRODUCTION OF THE EURO AS A CURRENCY IN POLAND?













