Description				

Provide a short description of the event and its activities.

The public presentation of the results of the public consultations in Poland took place on June 30, 2023 in the premises of Państwomiasto social and cultural hub. Miłosz Hodun was the main host of the event. He presented the results of the public consultations and moderated a discussion with the public. The consultations, taking place in April 2023, consisted of in-person, one-on-one interviews with 308 participants from the regions of Poland, following a set of pre-prepared questions on the various aspects of the rule of law and the covid-19 pandemic, followed by feedback and questions of the participants. In order to ensure representatives of the answers and the subsequent research, these in-person interviews were accompanied by online surveying.

Unexpectedly, the participants were very interested in the research methodology (only one of them was an expert in sociology/quantitative polls). They asked multiple questions about how the indexes were created (e.g.OTS, EUA, EUK) and requested explanations about particular questions that were used in the construction of the indexes.

In general, event participants were surprised about the levels of trust Polish people declare in different institutions. For many, the most surprising was the fact that NATO and the army are the most trusted, and the relatively high position of the police (especially in the context of the reaction of the police after the pro-abortion and LGBTQI+ rights protests.

Event participants found it very interesting that public consultations participants believe that the least protected minorities in Poland are people with disabilities (46%) and the homeless (46%), and that 36% say it is not protected enough. Additionally, they were surprised that so many participants of the public consultations believe that the rights of Jewish and Roma people and protected (two members of the Jewish community were present and gave longer comments about their experience).

Most of the participants spontaneously gave very positive feedback after the event. All of them said that they have never had access to this kind of data/information, and they would like to be informed about the development of the project. Three participants asked for access to detailed data to be used in their academic or professional work.
